

**Discussion:** We received the following proposal from a former president of the Boeing Employees Rifle and Pistol Club:

I am the former president of the BER&PC down south (2014-2016) and was laid off from Boeing in 2016. I was recently accepted back into Boeing in Everett and want to join your club. The membership is going down on the club down south and I was wondering if we could fold our club into yours to include our assets to include bank account and materials. Show and Tell: Ronnie Draughn brought a surplus refurbished 1911 he obtained from CMP (the Civilian Marksmanship Program). They had 19,000 applications for 8,000 available pistols. The cost was \$1050 for "service grade."

Sales Tax Information: The secretary brought to the meeting's attention that Washington state is now requiring out-of-state retailers to report sales shipped to Washington. It is unclear how out-of-state retailers can be compelled to comply with a Washington law but, since this isn't a tax, it isn't prohibited by the Supreme Court's "Quill" decision. As a result, the state's Dept. of Revenue may come looking for Use Tax (that's sales tax that we're supposed to pay on out-of-state purchases). One firm that is sending the reports is
